### a) Extension of Autonomous Status

The application for the renewal of autonomous status has been submitted to UGC as well as JNTUK on 18-03-2022 and the UGC team visit is awaited.

### b) NIRF India Rankings 2023

- The Registration of our institution for NIRF-2023 (8<sup>th</sup> Edition) under Engineering, Research and Overall categories has been completed on 04<sup>th</sup> Nov. 2022.
- As Data Capturing System (DCS) is opened on 28<sup>th</sup> Nov. 2022, the collection of information pertaining to different parameters of NIRF Application is under process and likely to submit well before the deadline 06<sup>th</sup> Jan. 2023 given by NIRF.

### c) NBA

- The Department of Mechanical Engineering has been accredited by NBA (with secured score of 730/1000) under Tier-I from A.Y. 2022-23 to 2024-25.
- NBA has accorded accreditation to the B.Tech. CSE, IT, ECE & EEE Departments from A.Y. 2022-23 to 2024-25 after compliance reports followed by visit of NBA Team. Self-Assessment Reports (SAR) of NBA for B.Tech. Aerospace Engineering, Civil Engineering & MBA programs were submitted on 07<sup>th</sup> Sep. 2022 and Expert Team visit is awaited.

### d) NAAC

Details of NAAC Grades during last two cycles were presented: 'A' Grade with score 3.09/4 in 2013, 'B<sup>++</sup>' grade – 2.96/4 (Cycle-2) in 2018 and 'A' Grade – 3.20/4 (Cycle-2 - Reassessment) in 2022.

- Decreasing intake of B.Tech. ME from 120 seats to 60 Seats.
