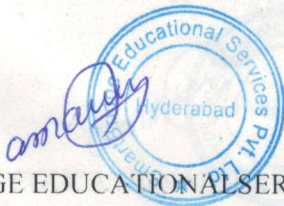

1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

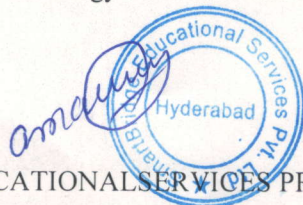
CLAUSE 2

SCOPE OF THE MoU

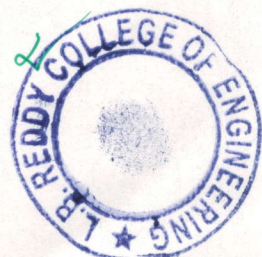
